Key Responsibilities

Fundraising Strategy & Execution

- Develop and implement annual and multi-year fundraising plans aligned with strategic priorities.
- Drive a diversified revenue portfolio, including major gifts, annual giving, planned giving, events, grants, and corporate sponsorships.
- Track and report progress toward revenue goals using data dashboards and metrics.
- Support fundraising for special initiatives, capital projects, and endowment-building efforts as approved by the Board.

Donor Cultivation & Stewardship

- Identify, cultivate, solicit, and steward individual donors, with emphasis on mid-level and major gifts.
- Partner with the President & CEO on key donor relationships and solicitations.
- Ensure timely, personalized donor communications and acknowledgments.
- Maintain and grow a robust donor pipeline through strategic outreach and relationship management.

Grants & Institutional Funding

- Work in collaboration with Development Consultant to research and pursue grant opportunities aligned with the Institute's mission.
- Write compelling proposals and manage timely reporting and compliance in partnership with program and finance staff.
- Maintain a grants calendar to track deadlines and reporting requirements.

Events Management

- Lead planning and execution of the Institute's signature fundraising dinner and other development events.
- Oversee event strategy, logistics, sponsorships, guest experience, and post-event cultivation.

Team & Board Collaboration

- Collaborate with program and communications teams to align fundraising messaging with impact storytelling.
- Serve as liaison to the Board Development Committee and support Board and staff fundraising engagement.
- Supervise development consultants, grant writers, and interns, as applicable.

Data & Systems Management

- Oversee donor database (NeonCRM), ensuring data integrity, accurate tracking, and effective segmentation.
- Generate reports to support decision-making and donor engagement strategy.
