Volunteering with the BakerRipley Tax Center is a significant commitment that requires a substantial investment of time and effort. Each of our volunteers embarks on a journey that begins with a thorough orientation and extensive training process, ensuring they are fully prepared to serve our community effectively.

The first step for all new volunteers is a one-hour orientation designed to introduce them to BakerRipley's mission and operations. This crucial step provides an understanding of the agency and sets the stage for the more intensive training that follows. The mandatory training for all new volunteers is comprehensive and rigorous, reflecting the high standards we uphold in our services.

Most volunteers opt for the in-person training, which spans 12-16 hours. Volunteers can choose between two options: a two-day intensive course, or a series of three evening classes. These options accommodate the varied schedules of our volunteers, many of whom are full-time employees or students. For those who prefer a more flexible schedule, we offer an online training program that can take as little as 12 hours, but typically requires about 20 hours due to its self-paced nature.

After completing their initial training, volunteers must pass a series of certification exams. The Standards of Conduct and Intake/Interview and Quality Review exams ensure that all volunteers understand the program's guidelines and ethical standards. Those who wish to assist with tax preparation must also pass the Advanced Tax Prep Exam, a challenging test that involves completing tax returns and answering detailed questions about them.

The certification process alone can take several days, with volunteers often splitting their exam time to manage the complex and detailed questions. This rigorous preparation is essential for ensuring that our volunteers are equipped with the knowledge and skills necessary to provide high-quality service to our clients.

Once certified, volunteers begin their hands-on work at the tax center, where they continue to learn and refine their skills on the job. This practical experience is invaluable and further enhances their ability to assist clients effectively. The commitment of our volunteers extends far beyond their initial training. Many contribute hundreds of hours each tax season, with some individuals donating over 500 hours of their time this year alone.

We are incredibly proud of our volunteers and their unwavering commitment to our cause. Their dedication not only supports our mission but also transforms lives, one tax return at a time.
